
### **Easy Read**

#### **About this booklet**



This booklet is from the Department of Justice of Northern Ireland.



We are part of the government of Northern Ireland.



We want to make a new law to help **victims** and **witnesses** of crimes get the help they need when they need it.

A **victim** is someone who is harmed or injured because of a crime.

A **witness** is someone who saw a crime or has information about a crime.



We are writing a document about what the new law should include. This document is called the **Victims and Witnesses of Crime Bill**.

## Questions for you to answer

Idea 1



Our first idea for the new law is to make a new job called the **Commissioner for Victims and Witnesses of Crime**.



A **commissioner** is in charge of checking that certain organisations are doing their work well.



The Commissioner for Victims and Witnesses of Crime will check that the **criminal justice system** is meeting the needs of victims and witnesses.



The **criminal justice system** is all the different organisations involved in dealing with people who have broken the law.



The Commissioner for Victims and Witnesses of Crime will focus on checking that the needs of **vulnerable** victims and witnesses are being met.



**Vulnerabl**e people are people who need extra support to stay safe.



In this booklet, we will call the Commissioner for Victims and Witnesses of Crime, 'Commissioner'.

The Commissioner's duties will also include:


• Checking that laws meet the needs of victims and witnesses.


**Review** means checking the rules working and being followed.

The Commissioner will not be involved in victims' and witnesses' individual issues.




Instead, they will look at bigger issues that most victims and witnesses deal with.



If the Commissioner thinks a victim or witness is in danger, they can tell an organisation about it, who can help the victim or witness.

**Defamation** is when someone says something about another person or group that might make the person or group look bad.




This means the Commissioner can share information they have found out, even if it makes an organisation look bad.

We will ask organisations to show us that they are following the new rules for meeting the needs of victims and witnesses.

If they do not do this, they will be breaking the rules.

## Idea 3



Our third idea for the new law is to give more support to people who say they have been the victim of a serious sexual crime.



We would do this by giving the person a free lawyer for certain **pre-trial** hearings.



A **pre-trial hearing** is where a court makes decisions about a **trial** before it happens, like what information can be included in the trial.



A **trial** is where a court listens to all the information in a crime case and makes a decision about whether someone did a crime or not. We will give people a free lawyer if they are:



 Asking the court for some information to be removed from the trial.



 Asking the court to not allow their past sexual activities to be mentioned at the trial.

We want the new law to give people who say they are victims of serious sexual crimes the **right** to a lawyer at pre-trial hearings.




**Rights** are things that every person should have by law.

## Idea 4



Idea 4 is another way we will give more support to people who say they have been the victim of a serious sexual crime.



We will do this by having stricter laws about what information about the person can be used in the trial.



This is so that very personal and private information about the person cannot be mentioned in the trial.

When a crime case goes to trial, the person who is being accused of doing the crime is called the **defendant.** 



They will have their own lawyers. They are called the **defence team**.



Defence teams can use information that organisations have about the person who says they are a victim in the trial.



They can use this information to support the defendant.



But defence teams have to ask organisations for this information.

When asking organisations for information, we think defence teams should have to:



 Ask for the information the organisation has collected about the person within a certain time, for example between 2021 and 2022.

This is instead of asking for **all** the information they have about the person.



• Explain why they need the information and what it has to do with the crime case.



This will be part of the new law.
